<u>Old Business</u>: Report from the Foundation on the Capital Campaign Moved to New Business.

New Business: 1. Election of Chair and Vice Chair: Watne stated that he is stepping down as the Chair due to his pending retirement from the Board of Supervisors Nominations for Chair: Watne nominated Jacobs for chair Motion by Watne and Second by Lee to close nominations and select Scott Jacobs as Chair. - 2. Audit Report for approval: Report was receives yesterday morning and emailed to Commission members to review. Motion by Lee, second by Hill to approve report and put it on file with the State. APPROVED.
- 3. Discussion on the need for an attorney. With the changes in personnel and the review of the Region 28E agreement the commission felt there was a need to have an attorney available for assistance. Motion by Leffler and second by Lee to appoint Stu Cochrane as the Region's attorney. APPROVED 4. Presentation by Hergenreter on the Hazmat team calls.

5. Interview Committee: The committee reported that they had met to discuss Stickrod's position. After discussion it was decided to try the sharing of the position with the Fort Dodge Fire Department. This will be a full time position with the Region paying for half. This position will follow the City of Fort Dodge handbook. It was also requested that the job description be defined to keep the duties of the Region and the Fire Department separate and that the position have in place a probationary period in case it is decided that it needs to become a full time Region position again. An agreement will need to be put in place. It was also recommended that this person keep a log of duties completed each day. The Committee along with the City's HR person will interview the candidates and report back to the Commission who was hired. This person should be in place by May 1st to allow Stickrod time to train this person on the duties of the Region and use her vacation time before she retires.

6. Foundation report: Leffler reported that the Foundation met prior to the LEPC meeting to discuss the upcoming capital campaign. It was decided to design a one or two page flyer to take on visits. A fundraising list will be started with the largest companies in each county and other foundations, casinos and entities that may be potential donors. A tiered program will be set up with goals. Pledge forms will be designed. A 6 month campaign is the goal to reach the decided amount.
